Zeta on Monday joined the ranks of unicorns after it raised \$250 million in funding from SoftBank Vision Fund 2 at a valuation of \$1.45 billion. Sodexo also participated as an additional minority investor in the round that is part of the company's Series C investment.

The Indian start-up sector has added 14 unicorns this year. Zeta plans to deploy the capital to fuel its growth in India, US and Europe. Bulk of the proceeds will be used to scale its operations, team, and platform to meet the demands of an expanding customer base, it said.

Founded in April 2015 by Bhavin Turakhia and Ramki Gaddipati, the San Francisco and Bengaluru-based Zeta provides modern credit, debit processing, BNPL, core banking and

BHARTI AIRTEL ON Monday said its network is fully ready for 5G and also announced deployment of additional spectrum in Karnataka and Tamil Nadu to boost network quality.

The company has deployed 11.2 Megahertz (MHz) additional spectrum in Karnataka and 5 MHz in Tamil Nadu, both in the 1800 MHz band, popularly known as 2G spectrum.

"Airtel had acquired the 11.2 MHz spectrum for Karnataka during the recent auctions conducted by the Government of India. With this fresh spectrum, Airtel has the largest spectrum bank of 68.8 MHz in Karnataka.

Airtel claims to have over 3.03 crore customers in Karnataka and its network covers 97.5% population of the state. "Airtel now has the largest spectrum bank in Karnataka and our future ready network is well positioned to meet the surging demand for high speed data," Bharti Airtel CEO-Karnataka Sharan Shetty said.

It had also acquired large blocks of 1800 and 900 MHz spectrum for Tamil Nadu during the recent auctions. "With this fresh spectrum, Airtel has the largest spectrum bank of 65 MHz in Tamil Nadu," the company said.

Airtel claims to have over 2.7 crore customers in Tamil Nadu and covers 98.54% population of the state.

हिमाचल में करोड़ों की किताब खरीद की प्रक्रिया पर उठ रही उंगलियां

ओमप्रकाश टाकूर शिमला, 24 मई।

हिमाचल प्रदेश समग्र शिक्षा अभियान के तहत विभिन्न कक्षाओं के लिए की जा रही करीब आठ करोड़ रुपये की पुस्तकों की खरीद प्रक्रिया को कठपंरे में ला दिया गया है। किताबों के प्रकाशन और बाद में उनकी खरीद को लेकर अपनाई जा रही प्रक्रिया को लेकर कई सवाल उठ रहे हैं। कई साहित्यकारों का आरोप है कि भाजपा से जुड़े दिल्ली के एक प्रकाशक के इशारे पर यह सब हो रहा है। दरअसल, समग्र शिक्षा अभियान के परियोजना निदेशक की ओर से मार्च में विभिन्न प्रकाशकों और अधिकृत वितरकों से किताबों के नमूने आमंत्रित किए गए थे। नियम के मुताबिक इनमें कहानियों की किताबें और बच्चों की नामी पत्रिकाओं के अलावा बाकी किताबें भी होनी चाहिए थीं। प्रकाशकों और वितरकों को तीन श्रेणियों बुलबुल, कोयल और मैना के तहत ये किताबें परियोजना निदेशक के कार्यालय को भेजनी थीं। इनमें से बुलबुल श्रेणी के तहत पहली से पांचवीं कक्षाओं के बच्चों के स्तर की किताबों के नमूने मांगे गए थे जबकि कोयल श्रेणी के तहत छठी से आठवीं कक्षा और मैना श्रेणी के तहत नौवीं और 12वीं कक्षा के विद्यार्थियों के स्तर की किताबों के नमूने आमंत्रित किए गए थे। एक प्रकाशक चयन समिति के समक्ष विचार करने के लिए एक श्रेणी

के तहत दस किताबों से ज्यादा किताबें नहीं भेज सकता था। इसके अलावा जो किताबें राज्य परियोजना निदेशक को भेजी जाएंगी उन्हें वापस नहीं करने की बात भी थी। इन नमूनों को 20 मार्च तक राज्य परियोजना निदेशक के कार्यालय तक भेजा जाना था।

जानकारी के मुताबिक एक हजार के करीब प्रकाशकों और वितरकों ने परियोजना निदेशक को अपनी किताबों के नमूने भेजे। इस बाबत परियोजना निदेशक की ओर से एक चयन समिति भी गठित की गई और उसमें इन नमूनों को रखा गया। लेकिन आरोप लगाया जा रहा है कि यहां पर धूल झांकेने का ही काम हुआ और कुछेक को छोड़ कर बाकी जुगाड़ वालों की किताबों का चयन किया गया। सूत्रों के मुताबिक परियोजना निदेशक की ओर से केवल 50 के करीब प्रकाशकों और वितरकों की किताबों का चयन किया गया। इनमें में कुछ ही नामी प्रकाशक हैं।

उधर, प्रदेश के एक चरिष्ठ कहानीकार ने कहा कि इन पुस्तकों के चयन की समिति में तो लेखकों को होना चाहिए। प्रदेश के लेखक इस बाबत एक अरसे से मांग भी उठाते रहे हैं। लेकिन

खरीद प्रक्रिया रद्द करने की मांग

इस बीच अखिल भारतीय हिंदी प्रकाशक संघ के उपाध्यक्ष आरके यादव ने मुख्यमंत्री जयराम ठाकुर को चिट्ठी लिखकर कहा है कि नौ सौ से अधिक प्रकाशकों ने अपने प्रकाशन की श्रेष्ठ पुस्तकों को समग्र शिक्षा अभियान के कार्यालय में खरीद के हिसाब से विचार करने के लिए भेजा था।

भारत बायोटेक अपने कोविड-19 रोधी टीके कोवैक्सिन का बच्चों पर 'चिकित्सीय परीक्षण' जून से शुरू कर सकता है। कंपनी के एक वरिष्ठ अधिकारी ने यह जानकारी दी।

भारत बायोटेक के 'बिजनेस डेवलपमेंट एंड इंटरनेशनल एडवोकेसी' के प्रमुख रचेस एला ने फिक्की महिला संगठन (एफएलओ) के सदस्यों के साथ डिजिटल माध्यम से हुई बातचीत में कहा कि कोई भी टीका सौ प्रतिशत सुरक्षा नहीं दे सकता। उन्होंने कहा कि टीके के प्रभाव को सौ प्रतिशत तक बढ़ाने का लिए कोविड-19 से बचाव के नियमों का पालन करना होगा। उन्होंने कहा कि भारत बायोटेक को बच्चों पर टीके का 'परीक्षण' करने की अनुमति मिल गई है और इसे एक जून से शुरू किया जा सकता है। एफएलओ की ओर से रविशार को जारी एक प्रेस विज्ञप्ति में बताया गया कि एला ने कहा कि दो से 18 वर्ष की आयु के बच्चों पर 'परीक्षण' किया जाएगा जिसके लिए भारत बायोटेक को इस साल की तीसरी तिमाही में लाइसेंस मिल सकता है। उन्होंने कहा कि टीके के कुछ सामान्य दुष्प्रभाव हैं और इनके कारण किसी को टीका लगवाने से डरना नहीं चाहिए।
